General Information & Conditions of Entry

- 1. Entry Form must be completed honestly, accurately, legibly and SIGNED. Online registration is acknowledging and accepting all conditions.
 - 2. Use only one entry form per person.
 - 3. AGE IS DETERMINED BY THE AGE A COMPETITOR WILL BE ON 7 November 2013.
- If under 18 years of age, entry forms must be signed by **both Parents and Guardians**.
 WKF (World Karate Federation) rules will be applied to this tournament and modified at the discretion of the AKF Inc. Some events may be officiated using the Judge Mirror System. Referee Council reserves the right to apply modified rules.
- Competitors are responsible for their own Public Liability & Professional Indemnity Insurance including Participation (Member to Member) & Sports Injury / Accident cover.
- Children/Cadets/Juniors may not enter more than one (1) age/weight category.
- 8. Senior Kumite maximum age is 45 yrs.
- 9. * Veterans' Kumite 35 Yrs & Above Competitors 45 yrs and above must supply a medical clearance with their entry form.
- 10. The organisers reserve the right to combine or cancel divisions where there are insufficient entries.
- 11. Only NCAS (or international equivalent for international based coaches) qualified coaches will be permitted in the competition area and all coaches must wear club/state tracksuit. Coaches Registration Form must be completed and returned to the AKF National Coaching Director no later than 4 April 2012.
- 12. It is an AKF Inc. condition of entry that any competing athlete or attending coach is NOT under any current or existing performance enhancing drug sanctions from WADA or the relative agency/s of the country of origin of the competing athlete or attending coach.

- 4. WKF/AKF approved face masks Cadets (14 & 15 years) and ALL Children (9 13 years)
- 5. WKF/AKF approved body protectors All competitors.

- 1. Cadets, Junior, Seniors & Veterans Free choice Kata. Must not repeat Kata.
- 2. Children 13 years and under Free choice Kata. Can repeat Kata but not in consecutive rounds.
