**INSTRUCTORS** *must sign consent form* for 6<sup>th</sup> to 4<sup>th</sup> kyu Jiyu Kumite entrants.

- For Junior events Juniors are defined as being competitors aged under 12 years.
- For Senior kata events Seniors are defined as being competitors aged 18 – 39 years.
- For Master's events Master's are defined as being competitors aged 40 years & over.
- For Colts events Colts are defined as being competitors aged 12 - 17 years.
- Ages are taken as at **31<sup>st</sup> December 2013**.
- Events may be changed or combined depending on the number of entrants.
- 1st and 2<sup>nd</sup> place getters in 3-1st kyu events will be given the option of competing in Open events.
- For Kumite events, competitors 50 years and over must provide a medical certificate to the Tournament Organisers certifying that they are fit before being eligible to compete. The certificate must not be more than 60 days old and should be presented to the Organisers by no later than 9am on the day of competition.
- All competitors with 'medic alert' must report to the Tournament Doctor prior to competing to allow the Doctor to familiarise themselves with any special medical needs.
- **Conditions of Entry form MUST be completed and signed** or entries will not be accepted.
- Instructors must sign consent for 6<sup>th</sup> to 4<sup>th</sup> kyu Jiyu Kumite competitors.
- TEAM KUMITE EVENTS – Nominations and draws will be completed at the competition and run with time permitting.

## CONDITIONS

1. In these conditions : "the Association" shall mean and include Shotokan Karate International Australia Incorporated and Shotokan Karate International Australia New South Wales Branch, it's officers, servants or agents. "Opponent" shall mean any person competing against the competitor.
2. In consideration of the Association accepting my application to enter and compete in the tournament and in further consideration of my opponent competing against me, I hereby agree to abide by the conditions of entry, the rules, by-laws and regulations of the Association.
